Certification of Inability to Operate Due to Lack of a Quorum

In accordance with Executive Proclamation 52 JBE 2020, issued by Governor John Bel Edwards on April 30, 2020, the Louisiana Sales and Use Tax Commission for Remote Sellers (Remote Sellers Commission) is providing for attendance at Commission meetings via teleconference or video conference as allowed during the pendency of the COVID-19 health emergency. Pursuant to Section 4(E) of 52 JBE 2020, the Remote Sellers Commission will provide attendance for the 11 AM meeting on May 7, 2020 via Zoom and in a manner that allows for observation and input by members of the public, as set forth in the Notice posted on May 5, 2020. The Remote Sellers Commission is unable to operate in person in order to establish a quorum as doing so may result in violating Governor Edwards' order that all public gathering of 10 or more people be suspended or postponed.
